USO Y MANTENIMIENTO - USE AND MAINTENANCE

- Este producto contiene una fuente luminosa de la clase de eficiencia energética C. (@máx. carga 4000 K 70 CRI)
- La fuente de luz es atenuable por el driver suministrado con el producto continente mediante los protocolos de 0 – 10 V, PWM, Clock Dimming, Dali, Dali2.
- Para mantener un correcto funcionamiento de la luminaria se recomienda una limpieza periódica de la lente utilizando un jabón / detergente con PH neutro con un paño suave.
- La fuente de luz y el sistema de control independiente debe reemplazarse únicamente por el fabricante, su servicio técnico o persona cualificada equivalente. Precaución, riesgo de choque eléctrico. ⚠
- Se debe cortar el suministro eléctrico en caso de mantenimiento o manipulación para su instalación.
- Las luminarias están diseñadas para un alumbrado exterior y no debe ser usada en ambientes erosivos inflamables o explosivos.
- No usar las luminarias a un voltaje diferente a lo especificado en la hoja técnica / etiqueta del producto.

- This product contains a light source of energy efficiency class C. (@max. load 4000 K 70 CRI)
- The light source is dimmable by the driver supplied with the containing product according to the protocols of 0 – 10 V, PWM, Clock Dimming, Dali, Dali2.
- In order to maintain high efficiency may be needed cleaning of the outside of the lens twice a year using neutral PH soap / detergent with a soft cloth.
- The light source of this luminaire and the independent control system should only be replaced by the manufacturer, technical service or equivalent qualified person. Caution, risk of electric shock. ⚠
- The power supply must be switched off for maintenance or manipulation for installation.
- The lights are designed for outdoor lighting and should not be used in flammable or explosive erosive environments.
- Do not use the lights to a different voltage than the specified in the data sheet.
